## **Regulations Run for Help! Foundation Słonie na Balkonie**

### **I. ORGANIZER**

The Organizer of the Run for Help! hereinafter referred to as the Run, is the Foundation "Słonie na Balkonie", entered in the national court register under the number 0000409122 seated in Lodz.

### **II. OBJECTIVE**

1. Realization of programmer "Help children after traumas"
2. Promotion of activities.
3. Allowing sports competition for event participants.

### **III. DATE, PLACE, DISTANCE, ROUTE**

1. A competitor may take part in the Run four time per year.
2. Distances to choose from:

3 km - running or walking 10 km - run  
21,1 km - half marathon

3. The length of the half marathon is 21 km 0957m, with the Organizer taking 21.1 km as the appropriate distance for the Run (due to measurement deviations of time monitoring devices)
4. The competitor may cover the distance in any terrain, subject to the recommendations of the Ministry of Health regarding about COVID-19
5. Competitors are required to comply with traffic regulations.

#### **IV. PARTICIPATION AND APPLICATIONS**

- 1) Registration will be considered as registration in the Event registration system on the website [www.runforhelp.pl](http://www.runforhelp.pl) and the payment on Organizer's account for the selected starter package
- 2) Applications are accepted on the website [www.runforhelp.pl](http://www.runforhelp.pl)
- 3) Applications and payments will be made via the Datasport.pl portal at [www.runforhelp.pl](http://www.runforhelp.pl)
- 4) The participant is required to provide the current correspondence address in the application form.
- 5) To register, please complete the registration and application form. Immediately after completing it, you can make a payment using all the options offered through the PayU electronic payment operator and Blik. *Among the available payment methods are also traditional bank transfers or traditional international bank transfer onto account.*

- 8) Depending on the start package chosen, during registration the competitor will receive *a start number, diploma and commemorative medal.*

## **V. ENTRY FEES**

- 1) *Each participant pays an entry fee – 50 pln.*
- 2) *People living abroad, are obliged to payment of an additional fee for foreign shipment in amount of 30 pln.*
- 3) *Once paid, the fee is not refundable.*

## **VI. RULES / TIME MEASUREMENT**

1. The selected distance can be covered anywhere in the world.
2. *The competitor after the finished chosen distance, sends on email address: [pomagam@slonienabalkonie](mailto:pomagam@slonienabalkonie), the GPX trace with obtained during the run. The run should be recorded on any device recording time and distance through platforms responsible for archiving the training data such as: Nike Run Club, etc. or by giving in the email message: name and surname; made distance and run time. The organizer will verify the track in accordance with Fair Play rules.*

## **VII. CLASSIFICATIONS**

1. On the basis of the results submitted, the following classifications will be conducted, broken down into distance.

## **VIII. FINAL PROVISIONS**

1. Due to the specific conditions and rules of the Run, we urge you to comply with fair play rules.
2. The Organizer reserves the right to send Run Participants information about the Run and other events organized or co-organized by the Organizer, as well as for internal administrative and analytical needs.

3. The organizer reserves, as well as related entities, the right to use, free of charge, all photos sent by the Participants, film materials, interviews and recordings that can be placed free of charge on selected electronic media, catalogs and media: television, radio, newspapers, magazines, pages Internet for advertising and promotional purposes. The Participant declares that the Organizer is not and will not be obliged to pay any fees related to the activities described in points of this paragraph, thereby granting an unlimited license to use statements, information without notice for the purpose of advertising and promoting the Run.

4. The organizer reserves the right to amend the Regulations. The Organizer will inform about the changes in the Regulations on the Run's website.

5. In matters not covered by the Regulations, the Organizer decides.

6. If any of the provisions of the Regulations will be partially or fully declared void or impossible to enforce – all other provisions (in whole or in part) shall remain valid.

3. for purposes resulting from legitimate interests of the Solidarity Marathon Association:

- direct marketing of products and services
- handling requests and correspondence that you direct to us

- counteracting fraud and abuse

4. on the basis of your consent:

- sending marketing information (email / SMS)

### **Do you have to provide personal data?**

Providing personal data is necessary for your participation in the run. Refraining from providing personal data prevents the conclusion of the contract and participation in the race.

### **How long will your personal data be processed?**

Your data will be processed during the use of the [www.runforhelp.pl](http://www.runforhelp.pl) registration page and participation in races organized by the Foundation Słonie na Balkonie for which you will sign up by the website.

After the end of this period, your data will continue to be stored for purposes resulting from legal provisions (especially tax and accounting) as well as to prevent fraud and abuse and to pursue any claims arising from the concluded contract. Part of your data (especially those that are in the results of the race) can also be processed after this date for statistical and archival purposes.

### **Who will be the recipient of personal data?**

Your personal data will be disclosed to the Administrator's employees, associates and subcontractors to the extent necessary to achieve the previously mentioned purposes of personal data processing. Starting lists and results, containing basic personal data, will be publicly available, including published on the race's website.

### **What rights do you have regarding the processing of your personal data?**

You have the right to request: access to your personal data, rectification, deletion and processing restrictions. In addition, you have the right to object to their processing and to transfer them. In addition, in relation to processing that takes place based on your consent - you have the right to withdraw it at any time.

### **LEGAL BASIS:**

On May 25, 2018, Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of individuals with regard to the processing of data entered into force personal data and on the free movement of such data and repealing Directive 95/46 / EC ("GDPR").

The legal basis for the processing of your data is Art. 6 clause 1 lit. f GDPR (justified interest of the Administrator, which in this case is the promotion of the Association's activities) and art. 6 clause 1 lit. a and b GDPR, i.e. the consent of the data subject and performance of the contract to which the Participant is a party. According to the definition of personal data contained in the GDPR, the image is considered personal data, therefore it is protected on the principles contained in this act. In addition, based on art. 81 section 2 of the Copyright Act does not require the dissemination of the image:

a well-known person, if the image was made in connection with the performance of public functions, in particular political, social and professional (e.g. director, manager);

a person who is only a detail of a whole such as an assembly, landscape, public event.
